Jolly Archers Rules - Administration

1. The rules are to be issued to all new members and displayed on the Club's website and on the Club's notice board.

2. Minutes of Committee Meetings will be emailed to all members as soon as possible after approval.

3. Club records can be achieved from rounds:

- a)** Shot on Jollys target days. Rounds shot on normal club target days at other clubs will not be eligible to claim records.
- b)** Shot in Open Competitions. If they are set at Open competitions offered by other Archery GB clubs a completed and witnessed scoresheet or link to the results must be provided.
- c)** Juniors may obtain records for rounds by shooting the rounds appropriate to their age.
- d)** It is the archers' responsibility to submit claims for a County Record.

4. Shooting at away venues

If members shoot away from the Club and want to have the score included in their Jolly's personal record the round must be shot under Archery GB rules (in particular on a recognised Target Day). A completed and witnessed score sheet must be provided to the Records Officer. For scores shot in Open Tournaments a link to results may be provided. Scores from phone apps will not be accepted

5. Visitors shooting fees

- a)** The Target Fee for visitors is £10.00 for seniors and £5.00 for juniors. In order to shoot visitors must be current AGB members.
- b)** Visitors must have prior approval of two committee members and provide proof of AGB membership
- c)** Visiting archers may only shoot at designated times. During the summer season these times are, Wednesday 5:30pm to 7:30pm, Saturday 10am to 12.30pm and Club Target Days on alternate Sundays 10am -1pm. The dates of Club Target Days are available on the club events calendar. During the winter season visiting AGB registered visitors may attend our indoor shoots, please contact the secretary for information.
- d)** Senior club members may invite non AGB registered guests to have a taster session for a Target Fee of £10 (including use of club equipment). This must be agreed, in advance, by two committee members and reported to the secretary. At least two coaches; or senior club members with at least three years of shooting experience; must be present. Non AGB registered guests are not permitted under AGB rules to use their own equipment or to borrow equipment from club members.

6. Hire of equipment

- a)** Members bringing a guest into the club premises and using Club equipment shall be responsible for paying an additional fee of £5 to the Treasurer.
- b)** Beginners joining The Jolly Archers can usually hire equipment from the club. The charge is £10 per month (three months payable in advance) plus a deposit of £50 (£80 in total). We expect that beginners will buy their own equipment within three months. The deposit and any unexpired hire fee will be refunded upon return of the equipment in a satisfactory condition. Should the equipment be hired for more than 3 months the additional hire fees will be deducted from the deposit.

7. Keys to the car park at Jubilee Field

- a)** Requests for a key to the car park at Jubilee Field may be made by senior, AGB registered club members, once they have attended at least 20 club events (as defined in 5.c) and after at least 3 months of club membership.
- b)** The issue of keys is subject to a deposit of £30. This deposit will be refunded only upon return of the key. People leaving the club will be expected to return their key promptly. As per the Club's Constitution, failure to renew membership by 1st April will be viewed as leaving the club.

8. All members are expected to assist with the maintenance of the Clubs' facilities.

9. Signing-in

All Members and guests, upon entering any of the club's shooting venues, MUST sign-in in the book provided. This applies irrespective of whether the member is shooting or undertaking any other club activity e.g. coaching, maintenance, administration, field parties etc. Members should remind others arriving, to sign-in before shooting or any other activity. This is to conform to the regulations issued by HMRC covering clubs registered as Community Amateur Sports Clubs (CASC) which The Jolly Archers are and to comply with AGB rules regarding the monitoring of attendance at venues for insurance purposes.
